Research & Assessment

Research Canadian immigration regulations to determine if you meet the sponsorship requirements (income, relationship status, etc.).
Utilize government websites for official information.
Calculate costs associated with the process (application fees, medical exams, travel, etc.) and ensure you can meet them throughout the sponsorship period.
Gather evidence of your genuine and ongoing relationship, including photos, communication records, travel documents, etc.

Application Preparation

Download and complete the required application forms carefully, following instructions and format guidelines precisely.
Supporting Documents: Gather and organize all required documents (proof of income, relationship evidence, medical exams, etc.) ensuring they meet specified formats and translation requirements.
Narrative: Prepare a detailed "personal history" document outlining your relationship, meeting details, and commitment to sponsoring your partner.

Submission & Tracking

Submission: Submit your application package online.
Tracking: Monitor your application status through online accounts or by contacting IRCC. Be prepared for requests from IRCC for additional documents and information throughout the application processing.

Landing & Settlement

Landing Procedures: Understand and fulfill landing obligations upon arrival in Canada, including reporting to port of entry and completing immigration formalities.
Post-Arrival Formalities: Register for healthcare, obtain social insurance numbers, and complete other essential tasks.
Settlement: Research and secure housing, employment, and other necessities in a new environment.

Understanding Key Concepts

Sponsorship

The spousal sponsorship is a process by which a Canadian citizen or permanent resident sponsors their spouse or common-law partner to immigrate to Canada.

Sponsee (applicant)

The individual who is being sponsored and wishes to immigrate to the new country. They must meet specific eligibility criteria and demonstrate a genuine relationship with the Sponsor.

Sponsor

The sponsor commits to providing financial and emotional support to ensure the well-being of their sponsored partner during their initial period in Canada.

About the process

The sponsorship process involves demonstrating the ability to financially support the sponsored person, complying with legal obligations, and establishing a genuine relationship.

Who is an Eligible Sponsor?

To be a sponsor in Canada, potential applicants need to meet several key requirements divided in three main categories: **meeting eligibility criteria, possessing relevant documentation, and navigating the application process.**

You can sponsor your spouse if:

- You are a Canadian citizen, permanent resident or a registered as an Indian under the Canadian Indian Act
- You are at least 18 years of age
- You are not in receipt of social assistance or welfare (other than disability)
- You are not an undischarged bankrupt
- You have not been charged or convicted of an offense of a sexual nature or assault on a family member or relative
- You can demonstrate financial capability to support your spouse or common-law partner

Your obligation and undertaking are in effect for three (3) years from the date the spouse or common-law partner becomes a permanent resident.

Who can be Sponsored?

You can apply to sponsor your married spouse, common-law partner or conjugal partner.

Spouses

- Must be legally married
- Must be at least 18 years old

Common-law partners

- Is not married to you
- Is at least 18 years old
- Has been living with you for at least 12 consecutive months without any long periods apart

Conjugal partners

- Is not married to you
- Is at least 18 years old
- Has been in a relationship with you for at least 12 months
- Lives outside Canada and cannot live with you in their country of residence or marry you because of legal restrictions and immigration reasons.



Children 22 years old or older may qualify as dependent children if they are unable to support themselves financially because of a mental or physical condition, and they have depended on their parents for financial support since before the age of 22.

Post-arrival Services For Your Family
